2) Responses to Requests for Clarification

- Q1. The RFP often references the Dam Safety Reviews when outlining the scope of work. Could you make the DSRs available to the Consultant?
- A1. All the information required to submit a proposal is in the tender documents.
- Q2. It is stated that "Pre-construction site surveys are likely required for this project to determine presence of SAR." Is it the responsibility of the Consultant to conduct Species at Risk and fish surveys?
- A2. No, the Consultant is not responsible for Species at Risk or Fish Surveys.
- Q3. Will the Environmental Assessment be completed by PWGSC/PCA?
- A3. Yes, the Environmental Assessment will be completed by PWGSC. Consultant to provide PWGSC with information collected during the investigation and design that may be required to complete the Environmental Assessment.
- Q4. Is it the Consultant or the Construction Manager's responsibility to secure permits and approvals?

- A4. Consultant is required to obtain permits required to carry out inspections, investigations and design work. Consultant is required to submit documents under their authority that may be required to secure permits and approvals.
- Q5. On p.24, it is stated that the potential project to install turbines in select lock structures will be confirmed in June 2016. Has this project been confirmed? If so, could you provide additional information regarding the project and the scope of work that would be required by the Consultant?
- A5. The Hydro Power Generation portion of work will be excluded from the scope. Do not include any of this work in proposals.
- Q6. PR 2.6.1.1.9 (p.14) Which components of the dam aren't stable? We do not have access to the DSR.
- A6. Consultant to carry out inspection, investigations and analysis of structures.
- Q7. PR 4.2.4.2 (p.23) Which stabilization measures are identified in the DSR? We do not have access to the DSR.
- A7. Consultant to carry out inspection, investigations and analysis of structures.
- Q8. PR 4.2.7.5 What type of modifications would be required?
- A8. The Hydro Power Generation portion of work will be excluded from the scope. Do not include any of this work in proposals.
- Q9. PR 4.2.8.1 What changes would be required?
- A9. The Hydro Power Generation portion of work will be excluded from the scope. Do not include any of this work in proposals.
- Q10. PR 4.2.8.3 Will the structural requirements also be provided to the Consultant?
- A10. The Hydro Power Generation portion of work will be excluded from the scope. Do not include any of this work in proposals.
- Q11. PR 4.2.9.2 What condition deficiencies have been identified?
- A11. Consultant to carry out inspection, investigations and analysis of upstream and downstream approach walls.
- Q12. PR 4.3.5.1 What condition deficiencies have been identified?
- A12. Consultant to carry out inspection, investigations and analysis of upstream and downstream approach walls.
- Q13. PR 4.5.1.5.7 and PR 4.5.2.6.3 Do these studies only cover outlining the changes in the water flow characteristics? Is PWGSC/PCA responsible for SAR/fish studies?
- A13. Consultant is not responsible for Species at Risk or Fish Studies. Carry out studies as described.
- Q14. A DSR report is mentioned in the RFP documents at numerous locations. Can this DSR be provided to the respective Bidders?

- A16. Presentations will be combined with design concept and design development meetings to be held in Peterborough or Ottawa.
