BIDDERS CONFERENCE QUESTIONS AND RESPONSES

Q1: There are no page maximums for sections 3 and 6, is that an error?

R1: No that is not an error. Please do not supply a hundred page response. For those with a maximum number of pages, we mean pages of double sided printing.

Q2: DGM handheld mapping, do you mean the cart?

R2: No, it refers to an EM61 handheld device.

Q3: How is percentage involvement for Procurement Strategy for Aboriginal Business (PSAB) registered businesses audited?

R3: This information is contained at the following website: <http://www.aadnc-aandc.gc.ca/eng/1407949234714/1407949278067> PSAB representatives can provide support to bidders to understand these requirements, and bidders' are encouraged to get the contact information from Contracting Authority if desired.

Q4: At what point should an audit occur for a TAC like this?

R4: After several call ups are completed, if requested by PWGSC, then the audit would be for the total value of the work to that point.

Q5: Is rental of equipment considered to count towards the value of the work?

R5: If it is from a non-aboriginal firm then it does not count, if rental is from an aboriginal firm, then it does count to the value of the work.

Q6. In the TAC Annex "F" : Technical Evaluation, section 2b (page 5 of 12) there is a requirement for an organizational chart. "including description of each position in Annex "b" and how it will participate in this Contract." There does not seem to be any requirement (in Annex "F", section 2b or anywhere else in the TAC Annex "F") to identify the Key Personnel (e.g. PM, Project Geo, UXO PL) and/or provide CVs of the individuals who will staff these positions.

- Can you please confirm that there is no requirement to identify and provide CVs for key personnel for this TAC.

R6. The technical evaluation does not require the bidder to propose personnel for any of the positions on their organizational chart.
