A. Respond to question 1 received

Question 1: Can you be more specific as regards to the certificates / certifications required in Section 5 of the RFP? What do we need to provide? Where do we find the forms, if necessary? What is to be provided when we have never been convicted of an offense?

Answer 1: Under the Ineligibility and Suspension Policy, the Government of Canada requests that bidders, having been convicted of an offense, complete the declaration form (<http://www.tpsgc-pwgsc.gc.ca/ci-if/formulaire-form-eng.html>). If the bidder has not been convicted of an offense, he does not need to submit a form to meet the requirements of sub-article 5.1.

At article 5.2.1 Integrity Provision, the Government of Canada asks the bidders to submit, if it is a privately owned corporation, a list of the owners, or if it is a corporate entities, a list of the board of directors. The list could be received at bid closure, but **shall** be received before the award of the Contract.

All other terms and conditions remain unchanged
