Questions and Answers

1. Will the contractor be able to use non-stockpiled material from the offsite soil treatment facilities (borrow areas) to backfill the remediation excavation areas. Please also confirm that the soil can be utilized at no cost?

Yes - granular material will be supplied free of charge from the JJJ Pit for STF construction and backfill of the excavations at Fireside. Areas / pit faces available to the Contractor for extracting granular material will be identified to the Contractor by the Departmental Representative. No existing piles of granular material may be used. The Contractor is responsible for excavating, loading, transport and deposit of the material from JJJ Pit. If the Contractor uses supplied material from the JJJ Pit, the measurement will be in cubic meters (m³) as determined by the Departmental Representative. The STF may also be partially constructed in-ground to make use of the cut material for the berms. Screening of the PWGSC supplied material from JJJ Pit is not required.

2. A water supply well was identified in the area of one of the proposed excavations; how will this obstacle be handles, what will be the plan for the well and who is responsible to carry out required actions?

The water well will be decommissioned by others prior to Work for this Contract.

3. There are buildings and slabs in the area of one of the proposed excavations; what responsibilities are associated with building removal and slab removal, as well as any replacement?

The buildings be removed by others prior to Work for this Contract. The building slabs will be removed by the Contractor under Waste Oversize Debris Removal.

4. What responsibilities are involved with the excavation around or near the fiber optic line that is located in a proposed excavation area?

The fiber optic line will be moved outside the excavation limits by others prior to Work for this Contract
