Q1 – We are interested in responding to the above-noted tender call, but require further details for each item. We specialize in upholstered furniture and industrial upholstery. We are a social enterprise.

Ex:

Item 1. Wood Seating - Chair

Necessary information: wood specifications, foam, fabric, hardware. Do you have an image, a drawing or a product code so that we can assess the furniture? Will you be supplying some or all of the materials? Is labour for the upholstery all you are looking for? I am looking at your product catalogue and I can't identify the furniture for which you need subcontracting.

A1 – We don't have specific product models. We are asking the bidder to present us with at least one product in each category that meets the required specifications. The bidder must supply products ready to be upholstered by CORCAN. Ex. Item 1. Wood Seating - Chair – The bidder must supply the chair structure, custom tailored foam and all other necessary components (except the fabric) to obtain a finished product. CORCAN will do the upholstery and final assembly.
