1. Are the two sheds situated within the proposed excavation footprint to be demolished by the contractor prior to excavation or will this be completed by others? If by others, will the concrete pads also be removed?

2. Is the existing water well within the proposed excavation footprint to be decommissioned by the contractor or by others?

*Answered in previous amendments.*

3. Is the fibre optic line situated adjacent to the proposed excavation to be re-located by others prior to the work?

*Answered in previous amendments.*

4. Does PWGSC have contact details for the operator of the JJJ gravel pit?

*JJJ Pit is owned by PWGSC. Any questions regarding the JJJ Pit are to be directed to the PWGSC Technical Authority after Contract award.*

5. Are the buildings and concrete structures located over AEC#1 to be removed by others before contractors arrive?

6. Will the utilities (water well and piping and electrical, and fibre optic line) be removed from the AEC#1 area and anticipated excavation slope areas? If so, when will that be completed?

*Water well and associated equipment will be decommissioned by others prior to start of work. The fibre optic line will be moved prior to start of work.*

*Hazardous waste has not been identified in any of the samples. It is anticipated that we will encounter some HW, in the form of NAPL.*
