This Amendment 004 is raised to address questions. Please see questions and answers below.

### **Questions and Answers**

1. Is the successful contractor permitted to erect a temporary camp for personnel accommodation during the work at the Toad River Maintenance Camp?

*No, the remediation Contractor may not set up a temporary camp at the Maintenance Camp. However, the remediation Contractor may set up a temporary camp at the Stringer Creek gravel pit as determined by the Departmental Representative. The remediation Contractor is responsible for ensuring the temporary camp meets all requirements and is responsible for providing all services (eg power, water, sewage). If the remediation Contractor does not maintain their temporary camp in a manner acceptable to PWGSC (as the gravel pit owner), the remediation Contractor will have to remove their temporary camp and provide alternative accommodation at no increase to the Contract.*

2. Some quantities in the unit price table are in tonnes? Does this require us to install a scale at the location to determine proper weights?

*The quantities in the UPT that are in tones are anticipated to be either sourced or disposed of at off-site locations and that an off-site scale will be utilized (e.g., quarry, landfill, or Government scale). Use of an on-Site scale is at the discretion of the Contractor. However, for the purposes of measurement for payment, the scale must be certified in accordance with the Contract.*

3. Can we use material on site as Backfill-Import material?

No. However, backfill may be sourced from the Stringer Creek gravel pit as described in Amendment 003, Question 2.

4. If G. Baumeister Ltd is successful in the proposal will there be a guarantee that no liability will be on G. Baumeister Ltd when we place contaminated material in the cell which is provided but has a compromised liner?

*The Contractor is not responsible for the pre-existing condition of the STF. If the Contractor makes repairs to the STF, then the Contractor is responsible for these repairs as per the Contract.*
