This Revision No 001 to the Request for Standing Offers (RFSO) is raised to provide this questions and answers set no.1 and extend the closing date until 2016-10-26, 2:00 PM EDT.

Questions and Answers Set No.1

Question 1:

My dealership cannot become an authorized dealer, however we can purchase through our partner. Can we bid with our partner/supplier being the authorized dealer in this case?

Answer 1:

Yes. Under Article 5.1.2.1, sub-article 3, ii, the supplier can be a joint venture. Also under Articles 4.1.1.1 and 4.1.2.1, the Aboriginal business can be a joint venture.

Question 2:

- a) Can you confirm the number of call ups for this previous award for the past few years and the volume of each order?
- b) We hold national supply arrangements in other sectors under Aboriginal set aside and we experience lots of call ups each year. Why did we not get one call up during the time we held this RFSO previously?

Answer 2:

- a) For the current year, there was one call-up for \$80,000. There was also only one call-up for \$20,000 the year before.
- b) It is the client decision to make Aboriginal set aside. This procurement process allows for the establishment of the standing offer for outboard motors from Aboriginal businesses.

Question 3:

The standing offer closing date is before the manufactures date and this is not possible. The closing for the Aboriginal Standing Offer should be a week after the manufactures which will give us time to put it all together. Please confirm.

Answer 3:

The Government of Canada accepts to provide an extension to allow sufficient time to obtain and complete pricing.
