AMENDMENT 001:

This amendment is to publish a series of Questions & Answers regarding the Requirement of this Request for Proposal.

Note to bidders: Please be sure to include any and all amendments of this Request for Proposal with your bid.

QUESTION 1:

Could you please explain what you require in regards to electric forklift with retractable forks? Please specify if you are requiring one of the following fork attachment: Sideshifter / Fork Positioner / Sideshifting Fork Positioner?

ANSWER 1:

Sideshifter.

QUESTION 2:

Please advise if you require a gross capacity of 3,000 pounds or a net capacity of 3,000 pounds, which includes the attachment at maximum fork height?

ANSWER 2:

The forklift should be within a 3 000 pounds net capacity.

QUESTION 3:

Please advise if a vinyl rain protection would be adequate or are you requiring a full steel cab with wipers?

ANSWER 3:

We require a full steel cab with wipers.

QUESTION 4:

Is the requirement for a sit-down counterbalance truck? If yes, can you please provide a clearer definition of 'retractable forks' as this is not a standard offering for a Counterbalance?

ANSWER 4:

We do not need a counterbalance truck.

QUESTION 5:

Will the truck be operating outside in the rain? If yes, it is not recommended to use an electric truck, outdoors in the rain. If outside, what are the conditions (i.e. pavement, gravel, etc.)?

ANSWER 5:

In general way, the forklift will be used indoors. If outside, the forklift will ride on the sidewalk.

QUESTION 6:

In Requirements, you have asked for a height of lowered mast of 118 inches. Can you confirm this is the maximum height allowed and that the mast does not actually need to be that high? For example, to reach 188 inches, a triple tier mast would be only approximately 88 inches high.

ANSWER 6:

The 118 inches is the headroom of the garage. An 88 inches mast is acceptable.
