SOLICITATION AMENDMENT # 2

THIS AMENDMENT CONSISTS OF QUESTION AND ANSWERS.

1. QUESTION AND ANSWERS.

Q1 – After taking a look through the tender specifications with regard to the above mentioned project, I see that there are a couple of spots where we would like to request review for alternate approval:

GENERAL NOTES; Bonding Agent and Mortar

SIKATOP 123 PLUS & SIKATOP 123 PLUS EXTENDED = **MEADOW-CRETE FNP** or **MEADOW-CRETE GPS**

S109; Concrete Tunnel Cross Section & Details

Waterproofing Membrane = **MEL-ROL LM** OR **MEL-ROL**

A1 - We will not be assessing the suitability of alternative materials during this Solicitation. Bidders are to price their bids according to the materials specified in the tender package. After contract award, the successful contractor is invited to submit data sheets for proposed material substitutions. If the use of the alternative materials is approved by the Departmental Representative, price adjustments will be made if necessary as per General Instruction 15 of the ITT.

Q2 – I wish to get clarification on the waterproofing/damproofing requirements for this project.

The specification section 07 11 13 makes reference to waterproofing protection course and Bituminous damproofing. On the drawings there are references to “waterproof foundation coating”. Are these in fact the same item?

- See note 1 below;

The specification section on Bituminous damproofing lists material items for damproofing as well as waterproofing. Where are each item required? I can see no indication on drawings to differentiate between the two.

- See note 2 below;

The drawings make reference to “10 mm protection board”. The only reference i can find in Specification is for a 2 mm protection board.

- See note 3 below;

After the damproofing/waterproofing membrane is applied is the protection board required for vertical as well as horizontal sections?

- See note 4 below;

Is the drainage course required for any horizontal sections or just the vertical sections?

- See note 5 below;

A2-

1. There is both Waterproofing and Damp proofing
2. Damp proofing is only to be used on the replaced ventilation shafts for the magazines and ready rooms (8 total, 600mm x 600mm with various depths) – Detail 9 on drawings S108. All other concrete surfaces are to have the noted waterproofing membrane.
3. The 2mm reference in the specification for the protection board is incorrect. All protection board to be 10mm
4. In general protection board is only required on the horizontal surfaces not the vertical - See Detail 7 on S108 for typical arrangement. The only time this is different is a small vertical section on the high wall in front of the magazines - See Detail 8 on S108.
5. Drainage course to be provided on all sides of the structure including horizontal.
