SCOPE OF WORK / DELIVERABLES:

The scope of work consists of the furnishing of all plant, labour, equipment and material for the Contaminated Soil Removal at Cape Spear, NL. The project is to be completed in strict accordance with the specification and accompanying drawings, and subject to all terms and conditions of the Contract.

In general, work under this contract consists of, but will not necessary be limited to, the following:

- 1. Excavation of PHC impacted soils;
- 2. Recovery, transport and disposal of all excavated material at an approved landfill or soil treatment facility;
- 3. Backfilling of the excavation site;
- 4. Supply and installation of wooden protection posts with reflective tape and eye bolt rings.
