## AMENDMENT NO. 005

This amendment is raised to answer Bidders' questions.

### QUESTIONS AND ANSWERS

- Q5. M1 Corporate Capacity, with respect to point (2) Have an initial minimum value of \$2,000,000 (Cdn) before taxes, not including amendments. As this is a Tier 2 requirement we assume the intention of placing the initial contract value of \$2 million in the requirement is to demonstrate that potential vendors have provided similar services for a Tier 2 contract. We had a contract that meets all of the requirements of this M1 requirement with the exception of the initial contract value of \$2 million. However, due to the client's requirements their anticipated spend fell short of their requirements and as such, an amendment was issued to this contract the brought the value from just below \$2 million (before taxes) to well in excess of \$2 million (before taxes). No extension to the duration of the contract was granted at that time and in order to successfully amend the contract the client had to seek permission from the appropriate channels. If the spend had been appropriately identified, this would have been considered a tier 2 procurement and awarded as such. Given these circumstances would the Crown consider allowing this contract with the amendment that increased only the dollar value of the contract as having met this requirement?
- A5. We will not accept an amendment even if it was only for increase of funds and not a date extension. Therefore Canada will not change this clause as requested.
- Q6. In regard to the bid submission format for **resource** matrices for the RFP and keeping in mind Canada's Policy on Green Procurement; we would like the Crown to confirm if it is acceptable to submit our response using cross reference to resume or what is known as short-form grids.

An example of how we would like to submit our resource matrices is as follow.
