This Revision No 001 to the REQUEST FOR BID (RFB) is raised to provide this questions and answers set no.1 and make the following changes:

Questions and Answers #1

- 1) Please advise all panel heights? You are asking for overhead bins on some but all the panel matrixes shown are all 36"high.
*Definition of panel heights can be found in Annex A-1.1 Clause 3.4 as follows:
 "Panel Heights are identified as Base Panel Height, Work Surface Privacy Height and Seated Privacy Height and are defined as follows:
 3.4.1 Base Panel Height – must be within the range of 711mm (28 in.) to 965mm (38 in.) inclusive.
 3.4.2 Work Surface Privacy Height – must be within the range of 1065mm (42 in.) to 1219mm (48 in.) inclusive.
 3.4.3 Seated Privacy Height – must be within the range of 1270mm (50 in.) to 1371mm (54 in.) inclusive."*
- 2) If the lower 30" fabric section is removed on some panels then 6" will be visibly unfinished above the worksurface. Would it be acceptable to have this lower 30"panel height portion segmented and open (from 6H to 21H) aff.
I require easy and direct access to the wall receptacles and data ports below the work surface. Having a segmented panel with an opening (from 6"H to 21"H) below the work surface is acceptable.
- 3) Some items requested are category 6 however we don't have a category 6 on our SA, will you accept non SA items?
No, we cannot accept non SA items. Your bid will be evaluated on a per category basis and therefore you are not required to provide items in all categories.
- 4) Can you advise who created this drawing and panel matrixes?
The furniture placement was created by our project team. The panel matrixes was created by our project team in accordance to the SA.
