This Solicitation Amendment 006 is raised to incorporate Questions and Answers received.

All other terms and conditions remain unchanged.

Q1.) Refer to Annex D Evaluation Criteria – D.2.3 Management of Services “Information that should be supplied: **Profiles** of the key positions (specific assignments and responsibilities) for personnel other than key personnel.” Is there any guidance as to what the reviewers are expecting for the “profiles of the key positions”, and how will the profiles be evaluated?

A1.) There is no specific guidance. Note that D.2.3 states “The Bidder is also to identify sub-consultant disciplines and specialists required to complete the consultant team”. This is an opportunity for the Bidder to identify and profile specialist personnel that are not identified as Key Personnel, but who the Bidder believes would complete the Bidder’s team and provide additional capability.

Q2.) For the project examples, are we permitted to use a relevant project example from a team member that was not completed while working at the current bidding company (i.e. completed prior to working at Secure Energy Services)?

A2.) No. For D.2.1, the description is “Describe the Bidder’s accomplishments, achievements and experience as prime consultant on projects. A project is considered to be work the Bidder conducted at the same site for the same client even though the work may span several years and involve different phases.” So if a team member had worked for company A, and joins company B, and company B is a Bidder, the Bidder cannot claim projects performed by company A.

For D.2.1, the experience of key personnel is not restricted to experience with the Bidder, but rather that individual’s career experience regardless of company.
