**Questions and Answers**

**Q1.** The tender indicates that transport and placement of screened material suitable for the Soil Treatment Facility is paid under cost item 16. Can the oversized material removed during screening stay at the screening area(s)? If not where will it be relocated, and under what cost item will the relocation of this material be paid?

Currently there is no item in the unit price table or defined in measurement procedures for relocating oversized material produced from the screening operation. Based on the Unit Price table, the owner has assumed that the entire volume of screened material will be placed into the STF. It is therefore assumed that the work associated with "Oversized screened material to be stockpiled within work area at a location determined by Departmental Representative" will be paid under a change order.

**A1.** *No, this is not the case. Relocating oversized material is included in the Unit Price Table and the Measurement Procedures. Specification Division 01 11 00 Section 1.1.11 includes "Includes stockpiling within work area as instructed by Departmental Representative.". Thus the Unit Rate for Excavated Material Screening Operation includes stockpiling of oversized material*
