Are you able to supply an AutoCAD floor plan?

#### Answer 2

#### Question 3

Knoll does not have a 54" wide panel – can we use a combination of 24" wide and 30" wide panels to achieve 54"?

#### Answer 3

Yes.

#### Question 4

Along corridors there are 2 x 30" wide panels connected together – can we substitute for a 60" wide panel?

#### Answer 4

Yes.

#### Question 5

There are 11 power poles request where Knoll only requires 9 – can we quote 9 instead of 11?

#### Answer 5

No, Statcan requires 11 as it is needed for the data cable.

#### Question 6

How many duplex outlets are required per station?

#### Answer 6

StatCan requires 3 per station

#### Question 7

The counts specified for cantilevers and post legs are more than required – can we modify our counts on our bid response?

#### Answer 7

No, StatCan requires the quantities that are requested.
