Amendment 001 is raised to respond to the following questions as submitted to the Contracting Authority:

### Question 1:

Security Clearance SI09 states: This document contains a mandatory security requirement for the performance of the subsequent contract (refer to clause SC01 of the Supplementary Conditions included herein).

Which SC01 states: All persons working on site must hold a Facility Access with Escort Security Clearance, this includes persons working to correct deficiencies or do warranty work, issued by RCMP Departmental Security. Refer to Annex D.

Our question is what is all involved to get a Facility Access with Escort Security Clearance? How long will it take?

#### **Response:**

Upon award of contract, the Project Authority will provide the Security Clearance forms to the successful Contractor with instructions for completion and submission. Upon submission of properly completed applications, clearances generally take approximately 1 week.

#### **Question 2:**

A formal request was submitted for acceptance of a product alternate in relation to Specification 07 21 13 Board Insulation (page 2 Part 2.2.1.1). The proposed product being: PlastiSpan 25 Expanded Polystyrene (EPS) Type-3 Plus 25psi.

#### **Response:**

Section 07 21 13 paragraph 2.1.1 of the project manual states that the board insulation must be an extruded polystyrene. Plasti-Fab is an expanded polystyrene product and for this reason, the request for alternative has been rejected. The long-term moisture absorption is a fundamental difference between expanded polystyrene and extruded polystyrene due to the structure of the insulation.
