This amendment is raised to modify Solicitation EW699-170946/A as follows:

2) Questions and Answers:

1. With reference to the page restriction, can PWGSC please confirm that the requirement to provide photos of equipment can be put in a separate appendix that is not included in the page restriction?
 - a. Confirmed, photos of equipment are not part of the 120 page restriction
2. With the volume work put out by PWGSC over the short term we find it necessary to ask for an additional 2 week extension to the Gordon Lake project. We require this extension to ensure we have considered all aspects of the project both in terms of the written portion and the estimated cost.
 - a) No, an extension is not being considered.

During the Bidders Conference for the Gordon Lake project, the topic of ice road construction was brought up and we would like some clarification on the following items:

3. Are members of the Tibbitt Contwoyto winter road joint venture (JVTC) permitted to bid on the Gordon Lake Group of Sites Project (GLG)
 - a. Yes, any interested party may submit a proposal
4. If so, they are constructing the road and hold the permits for the road and there is a perceived bidders conflict as they would be allotted the following advantage:
 - i. They will have the ability to use the Gordon Lake portion of the road after the main road has been shut down and prior to fully opening- ice degradation is predominantly south of Gordon forcing a shutdown of the road in its entirety. Being permit holders, the construction group would be able to keep certain sections open longer if they can demonstrate permit compliance
 - a) The JVWR is a consortium between 3 separate mines which have come together to build the road to access each of their mines (Diavik, Snap Lake and Ekati Mines). The consortium would not be bidding on this project. The JVWR Consortium has contracted RTL/DTR to construct the southern portion of the JVWR this year. RTL/DTR do not hold the permits for the road. Use of the road and rates are controlled by the JVWR and not their contractor.
 - ii. Constructors of the road would have access and permission to use the dome lake camp giving them the ability to stay close to the project without having to set up accommodations onsite. This may be utilized for some or all the GLG construction crew. This scenario will extend their ability to haul equipment and materials between sites on the ice roads and other bidders not part of JVTC do not have this advantage.
 - a) This is not deemed to create an unfair advantage or conflict of interest
5. Registered Carriers (RC)-. If these carriers are permitted to bid on the project and are providing pricing for other potential bidders, they have the ability to set pricing for carriage of goods such that they will price out the competition. This is a clear bidders advantage
 - i. Are potential bidders required to use the RC for: transport to, from, and across Gordon Lake? If so, does this preclude the RC from bidding the project?
