Questions and Answers:

Q: Is there a specific load rating given for the "Half Load Restrictions".

A: Refer to addendum #1.

Q: We need to run equipment over the existing tunnels - Please provide the current working weight bearing capacity of the existing tunnels.

A: Contractor is responsible to confirm the existing structure can safely support any required equipment.

Q: There is reference in the spec to Shotcrete – please clarify where this is to be used?

A: No shotcrete is required for this project.

Q: There is reference in the spec to providing security personnel to guard site after work hours and during holidays – this does not appear to be necessary as the institution have their own guards – please confirm this requirement can be removed from the spec.

A: Yes, the Security personnel for holidays and after hours can be removed.

Q: Water supply – with security and access restrictions it will be expensive to import our own water supply – please can we have permission to set up a backflow preventer on a hydrant inside the institution and use free issue water.

A: The Institution would consider giving access to water if it is metered and paid for by the contractor.

Q: Electrical power supply – with security and access restrictions it will be expensive to import our own power supply – please can we have permission to use free issue temporary power from inside the institution.

A: The Institution would consider giving access to electricity if it is metered and paid for by the contractor.

Q: Temporary heat – can we use the existing steam supply to provide temporary heat.

A: The Institution would not consider supplying steam it is a finite supply.

Q: Original drawing CB-B1-7 shows the detail below- please confirm if we cut on the red line and leave the yellow part in or do we have to remove the yellow part? If we leave the yellow part in place, is it acceptable to cut it 1" out from the wall and leave it protruding by 1"?

A: Contractor is to sawcut and make good as per detail on drawings.

The following revisions and clarifications to the tender documents are effective immediately. This addendum will form part of the contract documents.

Drawings:

1. **Drawing SP1:**
 - a. Replace note "Limit of work & access within the institution property. All truck access for hauling is limited to highway half load restrictions" with "Limit of work & access with the institution property. All truck access for hauling is limited to regional road restrictions."

2. **Drawing S000:**
 - a. Add note D04-1: 9. Contractor is responsible for testing of existing steel to confirm chemical composition and properties to develop proper welding procedure. Testing is to be performed by certified testing agency and welding procedure is to be developed by certified welder based on results of testing. Contractor is to retain the services of a certified welding inspector to verify all site welds.

3. The attached drawing 440/441-0, showing the services in the work area, is provided for general information purposes and is to be considered by the contractor for truck load impact, services locates and for any required excavation.
