- Bidders met at 180 Wellington, Site visit started at 150 Wellington
- Introduced myself and the technical authority.
- Bidders were reminded that this is Contract is for Snow removal only and to Review the SOW as each one is different for each site and there have been revisions
- Advised the bidders that Annex B is now the pricing scheduling and it is to be completely filled out, if no price insert the \$0, if pricing is missing (left blank) they will be non-responsive
 - Reminded the Bidders to complete pricing clearly and legible writing
- Advised the bidders that they need to complete Employee Information List in Part 6 by bid closing
- Remind bidders that Security of **Site Access is required at bid closing**
- **this may mean that you will be required to apply for Site Access for all employees that do not have Site Access or Secret by contacting Patricia Laville at 819-775-7436 or Jacinthe Gelineau at 819-775-7379 to ensure employees have minimum Site Access or Secret.**
- **It was suggested that the bidders start the application process for Site Access ASAP before the RFP closes and send in with their bids employee names that are cleared at Site access or Secret only and after award they could send in other names as they are cleared at Site Access**
- **Reminded all bidders that all names submitted had Site Access or Secret clearance, explained that if for example they sent in 20 names and one did not have the required clearance they would be deemed non-responsive.**
- Reminded all bidders to only Complete Part 6 – 6.2 list and not Part 7 names of Qualified employees
 - Advised bidders to review new Hazard Assessment Form (Annex H)
 - Advised bidders that Maintenance Schedule should read Annex D not E
- reviewed with the contractors on how to complete the Reference Chart concerning the years of experience, it should show 3 completed years up to the closing date of Sept 28/16; any date after the closing of this RFP will not be included.
 - reminded the bidders that the day, month & year is to be shown -- do not write “since such a year to present”
- The bidders were told that when the TA is reviewing the reference they will only try 3 times within 5 working days to contact them so that it does not hold up the process and the bidders were reminded that the reference show the proper names, telephone number and email address (contact info)

- Bidders were reminded that they contact their references to let them know that they will be using them and they were reminded to make sure the reference name submitted is still with that company or make sure they get the replacement name.
- Reminded the Bidders there is a Financial Security once awarded
- bidders were reminded to review Part 4 Evaluation of the RFP as this will show them what is required
- CA advised the bidders forward any questions in writing (by email or fax) to the CA 5 days before closing date.

The job showing was then conducted by the TA.

The site visit moved from 180 Wellington and started at 150 Wellington, Loading Dock.

Bidders were reminded that there is no stock piling of snow on any of the sites.

Bidders were reminded to keep the sites clear as per the contract and the attached site plan.

1. Steps by generator
 - The steps by generator needs to be clear as per the contract since they are used.
Also, the plastic cover for the generator wires needs to be kept clear.
2. At the SJAM, Are locked Salt Boxes are allowed?
As per the Property Manager at Sir John A. Macdonald, locked salt boxes are allowed on-site
