- 3) The following Questions and Answers were posed during the solicitation period:

Q1: In Section 3.2 of the Technical Evaluation - "Client and Project References" we are asked to provide 3 project references undertaken by key members of the project team. Does this allow us to provide up to 3 project references for each of our multiple team members?

A1: It only allows submission of 3 projects total, and in turn 3 reference letters for those projects respectively. Key members must be part of the teams on these projects.

Q2: In Section 3.3 of the Technical Evaluation - "Qualifications of Key Individuals" PWGSC have requested five specific resumes. Given the multi-disciplinary nature of the work would we be allowed to submit additional resumes for key positions and cross shifts that we see as essential for project success. If so, how would the scoring be modified to acknowledge these additional key roles?

A2: Additional resumes will not be evaluated

Q3: In section 02 41 23 – "Debris and Miscellaneous Removals", it is indicated that the costs are to be included in the payment item 02 41 23-1; however, there is no bid item with that specification reference. Is there a missing bid item? Or is it referring to the bid item (the last one) ID#4.4?

A3: the reference should read 02 41 32-1. Refer to amendment Basis of Payment here in at #2

Q4: Table 4.2 of the Tetra Tech report entitled "Jericho Options Analysis Rev02" quantifies the volume of soil to be treated from each APEC. Total volume of soil to be treated, per this table, is 7,854 m3. Given the reduction in volume of PHC soil to be treated from 7,800 m3 to 3,315 m3 per Amendment No 1, can a revised table that quantifies the volume of soil to be treated from each APEC, corresponding to the revised estimate of 3,315 m3, be issued?

A4: Refer to the revised PHC soil volume table attached at addendum 3.
