### **BidCentral Online Bidding for Subcontractors Sections and Divisions**

**(Bonding required as per the BidCentral Online Bidding for Subcontractors Rules of Procedure)**

#### **Electrical**

Combined bids only to include:

Division 26 – Electrical

Section 33 65 73 - Concrete Encased Duct Banks and Manholes

Section 33 65 76 - Direct Buried Underground Cable Ducts

Section 33 71 73.02 - Underground Electrical Service

BOBS Rules of Procedure, Appendix A Standard Exclusions for Electrical shall apply. General Contractors are to include as they deem necessary for any work excluded by a Trade Contractor. As a reminder Trade Contractors will be excluding (but not limited to) the excavation and backfill work and civil concrete (such as precast manholes and concrete for concrete encased duct banks).
