Response to Bidders' Inquiries:

Please find below a response to bidder's inquiries received to date.

1. **Item 1 in Appendix 1 – Unit Price Table it asks for Mob/Demob of Heavy Construction Equipment for a quantity of 3. Can an additional line item be included in this Unit Price Table to account for fixed items associated with the fixed initial costs to Mob/Demob that wouldn't apply to additional Mob/Demob do to work stoppages?**

This tender process is for a fixed price contract. The quantities provided are an estimate of the expected work.

2. **There are no depths of water indicated on the drawings or specifications in which the divers may be diving to. Can you please indicate the maximum dive depths expected to perform this work?**

The location of anchors on the tender drawing is shown at depths up to -20 m. Drawing FV-BW-001R01 is provided with better resolution of the site bathymetry.

3. **There are no requests for the supply of shackles for this project. Are shackles not to be provided?**

Please see amendment item #2,8,and 9 below.

4. **Will there be a requirement for a scale to be part of the supplied equipment sufficient to load test the mooring lines?**

Yes, contractor shall be responsible for supplying all equipment necessary to complete the work as identified in the specifications.

5. **If a scow barge is not required to perform the scope of work because the heavy construction equipment (crane barge) is suitable for both uses can unit items 8 & 9 be disregarded?**

Applicable unit rates should be provided for all equipment requested. All equipment should meet minimum requirements and be capable of handling the type of work identified in specifications. The owner or engineer will determine the equipment required to perform the scope of work.

6. **The hours of work are noted as 8 hours per day. Is this based on 5 days per week, 6 days per week or 7 days per week?**

The work requested is based on a standard 5 days of work per week.
