Amendment 001 – Meat and Poultry CFB Kingston, is being issued in response to Bidder's question and Canada's response.

Q1: *Delivery locations – is it to all the locations listed or one main point?*

A1: **All locations. Each call-up will specify the delivery location.**

Q2: *How often would we be expected to deliver? Once a week or more frequently?*

A2: **As often as needed from Monday to Friday. Estimate 3 times per week.**

Q3: *Minimum order quantities – we usually have a min to deliver to Kingston wondering if there is an idea of the size of the orders that we can expect. And would we be expected to deliver just one item?*

A3: **Our minimum is usually between 10-12 item for the 2 main kitchen which is Routledge Hall and RMC. The only time we will ask for a one item delivery is if we forgot something and we are in a rush to get it.**

Q4: *Confirmation of Periods:
Period A November 1st 2016 to January 31, 2017
It closes on October 14, 2016 – when will the winning bid be told that they have the contract?
Time would be needed to ensure that the product is stocked to meet your demand.*

A4: **Solicitation A closes Friday October 14th at 14:00. Expectation is that a Standing Offer would be awarded with 1-2 business days from bid closing.**

Q5: *If the bid requests fresh product and our product is frozen – how do we quote this product if we only have frozen?*

A5: **Offerors must provide product as identified in the solicitation. Products identified as Fresh (chilled) must be delivered as such and the same for those identified as Frozen.**

Q6: *Do “brand” names play any importance on the quoting process, I noticed that no brands were given. So there would be no preference.*

A6: **Specific Brand names have not been identified, all products provided under the Standing Offer must meet the specifications listed.**
