QUESTION FOR CLARIFICATION

Q1 Could you send us a copy of the bidders list, such that we could consider partnering with another consultant?

A 1 Public Works and Government Services Canada (PWGSC) procurements are tendered through buyandsell.gc.ca, the official distributor for the Government Electronic Tendering Service (GETS).

Buyandsell offers those interested in a tender to add their name to a List of Interested Suppliers. Please visit the tender page to determine availability of a Supplier's List.

Q 2 Section 3.2.3.1 reads "Demonstration that within at least the past (5) years, the Proponent has participated in a range of projects requiring a full scope of services in accordance with the Required Services (RS) section" What is the intent of this sentence? If the intent is to establish the experience obtained by the proponent within the last 5 years only, would it be possible to extend this to the last 10 years?

A 2 The intent is to evaluate that the vendor has recent experience, and recent is defined as to mean the past (5) years. Vendors may wish to include projects extending beyond the past (5) years, however the evaluation will focus on the past (5) years.

All other terms and conditions of the solicitation remain the same.
