This amendment 004 is issued to respond to questions from the industry and revise certain clauses in the RFP document as described below.

## **Part A – Question and Answers**

### **1) Question 006:**

Page 13 of the RFP states that a Volume III, Certifications, should be supplied with the bid. But page 25 of the RFP only lists one certification that needs to be supplied at bid submission time, that being “Integrity Provisions - Declaration of Convicted Offences”.

Should we still submit a Volume III, cover page, table of contents, bound, and so on, with perhaps a statement saying that we believe there are no certificates to submit? That seems like a waste, but I would not want the absence of a volume of our bid to be deemed as non-responsive.

### **Response to Question 006:**

The certifications required with the bid are identified under Article 5.1 to PART 5 - CERTIFICATIONS AND ADDITIONAL INFORMATION of the RFP document. Bidders are referred to Part B – Revision to RFP Document of this amendment for more information.

The certifications and additional information under Article 5.2 - Certifications Precedent to Contract Award and Additional Information to the RFP document, should be submitted with the bid.

## **Part B – Revisions to RFP Document**

### **1) At Part 5 of the RFP document, Article 5.2 is amended as follows:**

Delete sub-article 5.2 (d) in its entirety.

### **2) At Part 5 of the RFP document, Article 5.1 is amended as follows:**

Add new sub-Article (b) as follows:

#### **(b) Certification of Compliance**

The Bidder must submit a duly completed and signed Attachment 5.3 – Certification of Compliance as part of their bid.

**All remaining terms and conditions remain the same.**
