- 6- For E89P (Item 154), the P in the part number does not exist. Can you please advise which of the following Tactikka Headlamps by Petzl the customer would like?
- 7- Item #12 (NSN 8465-20-001-0465) has a listed Breaking Strength of 25kN, and the RFSO calls for a device with a Breaking Strength no less than 35kN. Can you please clarify that the requirements for breaking strength are correct?
- 8- Items #51, 52, 55, 62, 117, 121. The Acceptable Part Number items do not meet the weight specifications requested. Can you confirm the weight specifications are accurate?
- 9 Items #58, 60, 61, 62, 64, 65. The Acceptable Part Number items do not meet the range specifications requested. Can you confirm the range specifications are accurate?
- 10- Item #52 (Climbing Device Ultr). The Acceptable Part Number (UTCU104 Metolius Mountain Products) does not meet the sling webbing size specification. Can you confirm the sling webbing size specification is accurate?
- 11- Items #131, 132. The Acceptable Part Number items do not meet the weight specifications due to the fact that they have been discontinued and new products (P36BC 10, and P36BC 12 Petzl) have replaced them. Can you confirm the weight specifications are accurate?
- 12- Items #142, 143, 144, 145, 146, 147, 148 (Piton Mountain). Seeking confirmation on the material specifications. Does both the hanger and the screw need to be stainless steel, or does the stainless steel requirement pertain to only one part of the components?
- 13- Item #123 (Snap Link Rappel). The Acceptable Part Number (BD3810590000ALL1 Black Diamond) has been discontinued for 2016, can you confirm the specifications for this item are to remain the same?
