PRODUCTION PRINTER LEASE

Request for Propsal Amendment no. 002 is raised for the following reasons: Answers to questions.

Question 006:

On page 5, 1.1 Summary- It states that this requirement is for 1 Production class printer. On Page 20- Annex B it states "For the lease, delivery, configuration and installation of two monochrome production printers ". Can SSC/ DND please confirm that this requirement is for 1 or 2 production class printers?

Answer 006:

The requirement is for 1 production printer.

Question 007:

Can SSC/ DND please confirm where product substantiation should be entered? Would it be beside the "Met/ Not Met" on Page 27 – Annex G- Technical Compliance Form or on Page 17-30 Annex A- Statement of work? Can a table be added for substantiation purposes?

Answer 007:

Please see modification 002.

Question 008:

Can SSC/ DND please provide a Financial Evaluation for this requirement? On Page 20-21 Annex B- Basis of Payment we have room to enter our numbers for this requirement, but there is no Financial Evaluation to understand how this will in fact be rated.

Answer 008:

A vendor must meet all mandatory requirements and have the lowest evaluated bid. We will add all FMR's, option years and monochrome CPC to evaluate.

Question 009:

The proposed printer must provide meter readings and log usage data that include number of clicks by date of usage (simplex, duplex, paper size)

Would DND consider the ability to export and provide usage on total clicks by simplex, duplex, and paper size? Justification is that the vendor will know what the monthly volume is for invoicing purposes based on the previous total against the new total volume (both with dates indicated) so reporting dates is redundant.

Answer 009:

Yes this will also be acceptable.

Question 010:

The network interface card will not act as a DHCP sever (scanner only)

Can you please confirm you mean the network interface card will not act as a DHCP server?

Answer 010:

The network interface card will not be a server. It needs the DHCP protocol to get an IP address that is not static.

Question 011:

Can SSC clarify that it is looking for a single click cost per copy/print? I.e. letter sized output will be billed the same click rate as 11 x 17? Or can the vendor charge double click for 11 x 17?

Answer 011:

The clicks should be the same on either 8.5 x 11 or 11 x 17.

Question 012:

The evaluated volume is 200,000 impressions per month. Can the DND Print Shop comment on the anticipated growth or decline of print, copy, scan volumes over the next 5 years?

Answer 011:

The volume will stay about the same or go a little higher, we will not be decreasing in volume.

Question 012:

Under Annex A, A1. Generic Equipment: "The Proposed Solution must be compatible with Windows server 2003 and Windows 7".

Microsoft doesn't support Server 2003 for updates any longer and either do new technology products ex. Drivers. It is also our understanding the DND had to have all Server 2003 environments updated to Server 2008 at a minimum by end of July this year.

We ask that this requirement be changed to "The Proposed Solution must be compatible with Windows server 2008 and Windows 7".

Answer: 012:

DND is now on Microsoft Windows Server 2008, so we can change the requirement as follows Microsoft Windows Server 2008 and Microsoft Windows 7

Question 013:

The proposed printer must print at a resolution greater than the or equal to 1200 x 1200 dpi (or close to it) at 8 bit pixel depth & 256 shades of grey
