This amendment is being raised to distribute questions and answers from the optional site visit held on September 14, 2016, distribute the answers to bidder questions submitted by email, make changes to the tender documents and provide video links.

B) Site Visit Questions and Answers

Q1 There is a requirement in the contract for a registered Alberta Land Surveyor to conduct the survey. Since the survey will be conducted within a National Park does it have to be a registered National Land Surveyor?

A1 A nationally registered or Alberta registered Land Surveyor will be acceptable.

Q2 Are there sections of the fence the Parks would prefer get completed first?

A2 No, however pay special attention to environmental wildlife timing windows in the BMP.

Q3 The contract indicates that existing fence posts are to be removed that are not in sound condition. What are the post holes to be filled with?

A3 Post holes created from post removal can be left as is or posts can be cut flush with the ground surface. No requirement to fill post holes.

Q4 What determines/ classifies a sound post from and not sound post? Please clarify. Who is to determine this?

A4 Based upon recent information that will be confirmed by the survey prior to beginning work, the existing fence may have to be moved 1m inwards into the Parks boundary. However, if the fence can remain along the existing line, Parks Canada & the Contractor will collaborate on site following tree clearing to set an agreed upon qualitative baseline for post soundness. Posts leaning greater than 10 degrees off vertical, evidence of post degradation from repeated stapling, broken off at the base and so forth shall be considered unsound and are to be removed.

Q5 The contract documents state that the barb wire is to end on a post. Would a splice be accept instead?

A5 Wires should end on brace posts as indicated in the contract drawings. One splice will be permitted between braces if required. A splicing detail will be provided to the successful bidder.

Q6 Other Parks have specified that the bottom wire is smooth stranded wire, not barbed. Does the Park want this?

A6 No, the smooth wire is often utilized for Pronghorn. As they are not typically found in this park, we are requesting barbed wire.

Q7 If posts break off in ground upon removal, are they to be removed? Or can they be left in place?

A7 Acceptable to leave in place if remaining post is flush with the ground.

Q8 The contract documents indicated the wire to be installed on the post face directed towards the outside of the Park boundary. This would mean that there is only 1m width to run equipment along the clearing. Not enough room to drive vehicles for installation. Can the wire be attached to the inside face instead?

A8 On the existing fence, the barb wire is located facing the outside of the Park. Parks require it to remain so.

Q9 Are mitigation requirements, such as the use of bridge to cross streams or access matting for wet areas supplied by Parks, etc?

A9 No, the contractor is to supply all mitigation requirements to conduct the work as part of the contract.

Q10 What seed mix is requested by Parks to use?

A10 See below for sample seed mixes based on the location of the disturbance requiring seeding. Please note that there may be some variability in the final seed mixes based on seasonal availability of native seed.

Q11 Will the Parks allow extensions to posts that require the Parks boundary sign posted? If so, what? Or do those posts have to 8'?

A11 No extensions will be permitted. Parks require 8' length posts where boundary signs are to be installed, refer to contract documents.

Q12 Can Parks please clarify the dust control mitigations?

A12 Refer to Section 2.1.8 – Air Quality Mitigations in the Best Management Practices (BMP) document.

Q13 Does anything need to be cleared outside of the 4m width boundary or 3m access roads? What if trees are leaning in?

A13 No, if a tree hazard is encountered, contractor is to inform Parks who will decide to treat it as an extra or have park staff remove the tree.

Q14 Are staple guns allowed to fix barbed wire to posts?

A14 Yes, as long as the staples are installed accordingly to construction documents.

Q15 When will the 10% holdback for the contract be released? Every year?

A15 The holdback will be released once substantial completion is met, at approximately 95% completion of the project. For further details on holdbacks, refer to General Condition 5 – Terms of Payment >100K – Construction (R2850D).

Q16 What color of metal t-posts does the Park require?

A16 Standard brown or green colors are acceptable.

Q17 What is the required depth of the t-posts in water?

A17 Same as normal t-post depth as indicated in contract drawings.

Q18 Will there be landowners who are against the project?

A18 Preliminary consultation with neighboring landowners has already been conducted. All stake holders have indicated verbal approval and acceptance. Further consultation will be required if external site access routes are to be used.

Q19 Please clarify the grubbing requirement.

A19 Refer to section 31 11 00 Part 3 – Execution in the specifications.

Q20 Can we use doweled posts?

A20 No, it is understand doweled posts don't last as long as non-doweled posts. However tapered/pointed end is allowed.

Q21 Is leveling sections of the fence line and access routes allowed?

A21 No, as this is a National Park, the goal is to minimize environmental impact. Refer to contract drawings for mechanical vs walking/hand work access only.

Q22 Can rocks jacks be built in areas ground is unsuitable to drive posts?

A22 No, refer to contract documents for use of t-posts in unsuitable ground conditions.

Q23 Is there an obligation to re-establish internal access routes? If so, what are there lengths?

A23 Yes, refer to contract documents. Internal access routes must be brushed to a 3m width to ensure future access for Parks for maintenance. The four internal access routes that must be cleared are shown

with approximate brushing requirements on drawings E0001 (negligible brushing), E0004 (50m+375m light brushing) and E0005 (300m moderate brushing).

Q24 Are existing posts on the Park Boundary?

A24 We have recent information to believe that the existing fence is directly on the boundary line for the majority of the fence line. Which would mean the new fence would have to be brought into the Park 1m to allow the 1m outside brushing to be done within Park Canada's property. The survey done at the beginning of the work will confirm. Refer to Section 01 10 00, 2.8 Legal Survey & Construction Layout in the contract specifications.

Q25 Is the contractor required to remove old fencing at contractor's expense? How many old wire bundles are left? Can we provide a unit price or cash allowance?

A25 This contract item will be covered under section 01 21 00 - Prime Cost Sum. A price to conduct the work must be agreed upon by Parks before proceeding with the work,

Q26 Can we get in with ATV's to look at areas? Can the boundary be ridden by horse?

A26 No, ATV's are not allowed to review the fence prior to contract. Horses are allowed.

Q27 When does rutting along the fence line become an environmental concern and enforced?

A27 If there is rutting evident and the vegetation has been removed from the surface (i.e., bare soil exposed), the contractor is responsible for re-vegetating the site at the contractor's expense. Where rutting is occurring, Parks Canada will work with the contractor to develop site specific mitigations (e.g., matting, shoofly creation, timing, etc) to prevent further rutting and minimize disturbance.

Q28 Can we fence in the summer if we're not clearing?

A28 Yes, refer to BMP

Q29 What happens if we cannot get the required fence depth due to rock?

A29 Attempt fence posts along the line a feet or two on either side. If still rejected, attempt t-post. If continued problem in an area – contact Parks Canada project manager to determine options.

Q30 How long since the fence line was last cleared?

A30 At least 30 years except for a few isolated places.

Q31 What do we do with the farmer's fence along the boundary line?

A31 If other fence is present, it should only be running parallel with the Parks fence. Anywhere where a neighboring land owners fence comes in contact with the Park's fence, the connection should be re-established to keep cattle out.

Q32 Do we fence just to the lake water line?

A32 For lakes you would fence regularly to the low water line mark. For larger creeks and rivers, end fencing set back from the high water line, with detachable drift fencing extending to the low water line. Refer to Section 2.4 of the BMP for environmental mitigation measures when working in or within 30m of wetlands and/or watercourses.

C) Questions Submitted by E-mail

Q33 Could you please quantify the existing fence post that are in good shape and don't need to be removed as this will affect the price for the removal and disposal of existing fence scope .

A33 Based upon recent information, the existing fence may be located on the boundary line directly. In which case the new fence will need to be brought inwards 1m so that 1m brushing can occur within the Park's boundary on the outside of the fence. Therefore, 100% of existing fence posts can assumed to be removed at this time. Survey will confirm upon completion.

Q34 Could you please confirm the completion date of this project.

A34 Final completion of the project is set for March 31st, 2019.

Q35 Can you please clarify what is required for site security?

A35 Refer to section 2.18 Construction Signage and Safety. Also please review the note on drawing C0001 in regards to cattle. Cattle must not enter the Park at any time during construction.

Q36 What is the cost to use additional storage or work areas?

A36 No additional cost, however all work must be contained within the construction footprint. Refer to Environmental Best Management Practise (BMP), section 2.1.3. If additional space is required, it must be approved prior to use by PCA. Any damage to the vegetation must be fully restored at contractor's expense.

Q37 Are there any permits and/or licences required to be applied for this project?

A37 Business license is required for any contractor/ sub-contractor doing work in the Park. This can be purchased at the administration building. The business license will include vehicle passes that must be with every vehicle coming into the Park.

Q38 If we were to use the water from the park facilities , what would be the cost?

A38 There would be no cost to use water for construction purposes from Park facilities. Depending on the required amount will determine where the contractor can draw from within the Park.

Q39 Will there be any problems getting approvals from the department for the haul roads? Is there any specific route to use as a haul road?

A39 Access routes from within the Park have been indicated on the project drawings. Refer to contract documents, these routes must be brushed. Not possible to get a rubber tired vehicle down these access points in most cases. Would highly recommend reviewing a few indicated on the drawings. Potential access routes to the boundary line from outside the Parks have been indicated on the project drawings. We have been provided preliminary approval from neighboring landowners for access to the boundary line. Special conditions in terms of type of vehicle access, timing restrictions and frequency will apply to these access points if the winning contractor chooses to use them. Refer to contract documents. Parks cannot guarantee the use of external access routes.

Q40 Could you please provide little bit of specifics to what/where we are expected to provide for construction signage?

A40 Refer to section 2.18 Construction Signage and Safety. It is expected that the work area is adequately signed and roped off in the areas that the public may be able to access the site. I would suggest adding to this – Specifically highway crossing/machinery parking and along the boundary where a trail is present (park line trail near Horseshoe Trail).

Q41 Best management Practices/2.2.1.2 . Could you please elaborate on this requirement?

A41 The site needs to be evaluated and that the best material with the least environmental impact must be chosen. Ex. Metal posts are to be used in wetlands instead of pressure treated posts.

Q42 Are we required to do nest sweep if our construction activities are outside this window April 1 - August 31.

A42 Refer to BMP section 2.1.4 – Vegetation clearing is not permitted within the migratory bird nesting period of April 1st to August 31st. Therefore, nest searches are not requirement of the project. However, if an active nest is found incidentally during construction at any time of the year, stop work and notify Parks immediately. Additional mitigation measures will be determined by Parks Canada.

Q43 Are we allowed to mulch the cleared materials and spread it on site?

A43 Refer to specification Section 31 11 00 Clearing and Grubbing – Part 3. Execution and the BMP section 2.3 Vegetation Brushing/Clearing.

Q44 Will there be any need to import top Soil to the site ? The top soil source will be provided by Parks Canada? How far are these sources?

A44 No, there will be no need for imported top soil to site for this project and import of topsoil is prohibited.

Q45 There is a requirement in the spec for Marine Liability and Aviation Liability. Is it safe to assume none of the work will be done by air or boat?

A45 Refer to construction drawings. Some work required for this project takes place in marine environments (ponds, rivers and small lakes). The contractor may choose to utilize aviation means to conduct some of the work in which case Liability insurance would be required.

Q46 EllisDon would like to request an extension for the closing date

A46 A new closing date for the tender will appear with this amendment.

Q47 Is there any problems if we were to provide sanitary facilities within the site office area only or we have to provide multiple ones throughout the fencing line?

A47 Sanitary facilities can be provided along the fencing line where mechanical access is assessable only.

Q48 What are Parks Canada requirements for site office ? Do you require one?

A48 No, Parks Canada does not require a site office. However, refer to Section 01 10 00 – 2.6 Documents Required in the construction specifications must be kept on the job site.

Q49 During the pre-tender meeting , it was mentioned that an As built is not required . Under General Instruction Section 01 10 00 page 3 of 9 / 2.8.5 , it states that we have to provide as built. Could you please clarify.

A49 An as built drawing set is required as part of the contract under section 01 10 00 – 2.8.5 Legal Survey & Construction Layout.

Q50 What if our mobilization cost exceeded 10% . Do we get disqualified?

A50 Yes

Q51 In the pre-tender meeting , parks canada mentioned that they have spoken to the adjacent land owners who seemed to be receptive to the idea of granting us access through their properties . In the event of one or some of these land owners change his/their mind or start demanding a compensation for the use of his/their property , how parks canada will be dealing with this issue ? We had a very similar situation of previous project were one of the land owners demanded a compensation for the usage of the property. Please advise.

A51 Refer to question and answer 39. Parks Canada cannot provide compensation for work done outside of the Park boundary.

Q52 For the corner post , it asks for lag screws, can we use 6 inches spiral spikes instead (as leg screws about 10% strip)

A52 Yes, 6" spiral spikes are acceptable.

Q53 For clearing and grubbing , how many linear meters are estimated as it looks like it could be 30% more than as measured in the horizontal meters (plus that percentage is probably 2-3 times harder to do than normal clearing)

A53 Section 32 31 13 1.2.3 of the contract specifications suggests an allowance of approximately 5% over the horizontal distance for fencing (and similarly clearing) over the full length of the project, based on available ground data. Slopes vary from as steep as 1:1 to being flat, thus the Contractor is responsible for performing their own checks of the topography and developing a suitable contingency in their bid price to account for sloped terrain

Q54 Are all gates to be wire gates , meaning no metal or wood gates are to be used?

A54 Correct, refer to contract drawings.

Q55 Is the stipulation to only take out as much fence as you can replace going to be enforced year round (as it makes it impossible to clear the last 1 meter side unless we do it all by hand)

A55 It is the responsibility of the contractor to ensure no cattle enter the Park. That being said, potential to consider other means to prevent this (ie, temporary portable fence, etc)

Q56 Some of the competition at the meeting were suggesting to run a mulcher up the fence . Will this be allowed and if not what would be the penalty for doing it ? The attitude overheard was it is cheaper to say sorry than to get told no .Mulching an old fence line takes and obliterates both post and wire and surprisingly leaves almost no evidence if done by an experienced operator; but it will give several thousand dollar per kilometer advantage.

A56 Deliberate non-compliance with environmental mitigations will result in a Stop Work Order and could lead to costly delays. Furthermore, individuals could be charged with "Failure to take reasonable measures to prevent degradation of the natural environment and danger to fauna" under the National Parks Act 32(1). The existing fence posts are treated and will not be allowed to be mulched on site. They must be removed and disposed of appropriately.

Q57 I am just looking for some clarification on what specifically needs to be signed off by an Alberta Land Surveyor (ALS)? Would you be looking for a Construction Plan specifically drafted up for this project? Would having an ALS sign off on the construction drawings suffice or survey field notes suffice? Thank you for your time, I look forward to your response.

A57 Survey must be done by a registered land surveyor as we are defining a legal boundary. As far as who prepares the drawings as long as they are stamped by the land surveyor they can be prepared by anyone he/she designates.

Section 01 10 00 General Instructions

Remove: Item 2.10.3 Payment for mobilization and demobilization is lump sum, and not to exceed 10% of the contract value.

Add: Item 2.10.3 Payment for mobilization and demobilization is lump sum.
