Amendment 003 – Meat and Poultry CFB Kingston, is being issued in response to Bidder's questions and Canada's responses.

Reference: Item#10 Fresh Bologna, Beef, Cello wrapped 2 x 4.54 g Case

Q1: *Cello wrapped is not a term that we are familiar with. We would need a better explanation as to what this means this way we can quote and be comparable to the other vendors.*

A1: "Celo Wrapped" means vacuum packed sealed.

Reference: Item#16 Fresh Ham, Sure Slice 3 x 1 kg Case

Q2: *Sure slice, is not a term that we are familiar with. We would need a better explanation as to what this means this way we can quote and be comparable to the other vendors.*

A2: 1 Kg packages of stacked slices / 3 kg carton, Gas flushed packaging, 3 slices=57g

Delete: description

Insert: Ham, sliced (3 slices per 57g)

Reference: Item#24 Fresh Beef, Montreal Smoked Meat, 20 x 140 g Case

Q3: *The packing size appears to indicate a 5oz portion? Would like a better explanation on this spec.*

A3: As long as it is Montreal smoke meat and it comes in a case of 3 kg it will be accepted.

Delete: description and requested pack size

Insert: Beef, Montreal Smoked Meat, 1 x 3 kg

Reference: Item#27 Frozen Sausage, Mediterranean

Q4: *Not sure what Mediterranean means? Can we have an explanation or recipe so that we can quote and be comparable to other vendors?*

A4: Item will be deleted.

Delete: In its entirety.

Reference: Item#33 Frozen Pork Creton, Individually portion 30 to 50 gm

Q5: *This appears to be a spread, not a meat product. Is there a recipe for the product so that we can quote and be comparable to other vendors?*

A5: This is a pork spread that used to be very popular amongst French Canadians. Product must contain pork, milk, onions, garlic, salt & pepper, cloves, allspice and breadcrumbs.

Reference: Item#38 Frozen Grain - Feed Veal Cutlets, Tenderized, (from the leg, w/out cartilage, tendon or excess fat), 4 oz

Q6: *Under the Brand category it indicates that a National Brand Mandatory, what does this mean?*

A6: You can ignore the National Brand mandatory.

Delete: wording National Brand Mandatory

Reference: Item#46 Fresh Turkey Roll Boneless, skinless, 50 % white meat / 50% dark meat (w/out giblets), Canada A Fresh

Q7: *Not sure what the Turkey Roll means? Can we get a better spec?*

A7: Turkey Roll is Turkey that has been deboned, and the dark and white meat has been put together mechanically to have the form of a roll so you are able to warm it up and slice it to serve.

Reference: Item#50 Frozen Breaded Zinger Chicken Wings

Q8: *Not sure what a zinger wing is? Does this refer to the breeding? Again can we get a better spec to properly quote on this item?*

A8: Mild spice wing, seasoned, coated with flour, fully cooked.

Delete: description

Insert: Breaded Chicken Wings, mild spice, seasoned, fully cooked

Reference: Item#55 Frozen Breaded Chicken Breasts, partially cooked, real muscle, Thunder Crunch, 100 Gram

Q9: *Not sure what Thunder Crunch means?*

A9: "Thunder Crunch" – Natural Chicken Breast portion, double breaded and seasoned.

Delete: description

Insert: Double Breaded chicken breasts, seasoned, partially cooked, real muscle

Reference: Item#60 Frozen Stuffed Chicken Breast, Florentine

Q10: *We don't call ours Florentine, but it is the same recipe, will this be an issue?*

A10: Should not be an issue, just annotate the listing with your product name.
