On page 19, A.10.1 it states that the contractor must conduct address accuracy so that CIC can benefit from incentive postage rates. Please note that this is only possible if Citizenship & Immigration has an account with Canada Post. Mailing houses are not allowed to have an incentive lettermail account. If Cit & Imm does not have an account with Canada Post, the Canada Post charge will be regular lettermail. – please advise

**Answer 2)**

Citizenship and Immigration has a valid account with Canada Post.

**Question 3)**

Can you please confirm that the tax form prints 2/2 as opposed to the previous year when it printed 1/1 black

**Answer 3)**

Yes, one (1) sheet per address 2/2 printed front and back.

**Question 4)**

Can you please confirm if the forms have perforations or not; in the past, these forms had 2 of them.

**Answer 4)**

The forms **do not require** perforations.
