Q4. What observations data, if any, will be provided by ECCC? Will there be a cost associated with this?

A4. In addition to the data specified in point 3 above, the data for Canada will be provided from the ECCC's National Climate Archives. There is no cost associated with this.

Q5. Is the consultant allowed to use any or all of the project outputs (e.g. the gridded North American datasets) for future commercial use?
