Annex A

1.0 Response to Bidders' Inquiries:

- 1.1 Please find below a response to bidder's inquiries received as of Oct 4, 2016.
 - Q1: What are treatment of existing decking, stringers, piles and caps?
 - A1: Bidders shall assume decking is salt treated, stringers and caps are creosote and piles are untreated.
 - Q2: What is the average length of pile being replaced?
 - A2: Bidders can assume an average length of 2m. The range is approx. between 1-4m.
 - Q3: Referring to Section 01 13 00, 17, please advise which permits will be the responsibility of Contractor to obtain and pay for?
 - A3: No permits are required.
 - Q4: Is access to the work only available through the decking that is being replaced?
 - A4: There is access under Wharf 404 on the north side of Building 7 and on the east and west sides of Building 8. Access can also be made through the deck, subject to Owner approval. However, the Contractor will be responsible for replacing decking that is damaged during removal, at the Contractor's expense.
 - Q5: Do you have drawings or a cross section of what the wharf looks like?
 - A5: Cross sectional drawings are not available. Bidders are recommended to visit the site.
 - Q6: I believe the work will take more than 7.5 days with a 3-man labour crew, is the foreman included in the hourly rate or separate?
 - A6: Refer to specification amendment 2.1 and 2.2. All crew, including the foreman, are included in the man-day rate.
 - Q7: If we need confined space entry, we may need an additional person (non-working) to watch CO levels etc.
 - A7: There will no requirement for enclosed space work in this contract. If it is deemed required during the execution of the contract, then the owner will request an additional proposal for that grade of work.
 - Q8: Can the inspection report be provided to bidders and how did inspectors gain access?
 - A8: No inspection reports will be provided with this tender. Refer to A4 for accessibility.
