Section 01 14 00 1.3 USE OF SITE AND FACILITIES – Add the Following Change:

For use of site and facilities, one day work is permitted for all preparation work.

Section 01 14 00 1.5.2 EXISTING SERVICES – Change 48 Hours to 72 Hours as Follows:

Where Work involves breaking into or connecting to existing services, give Departmental Representative 72 hours of notice for necessary interruption of mechanical or electrical service throughout course of work. Keep duration of interruptions minimum. Carry out interruptions after normal working hours of occupants, preferably on weekends.

Section 01 33 00 1.5 ALTERNATIVES – Add the Following:

Request for alternatives may be submitted during the tendering process up to 1 week before closing of tender by submitting a written request. Alternatives must conform to performance and sizing requirements. For consideration of proposal alternatives, submit the following for review and acceptance by the Engineer.

- Complete shop drawing submittal, including performance, wiring drawings, dimensional data
- Control submittal, including control interface points, control wiring drawings, and sequence of operation.
- Details on local service capability of supplier, including number of technicians on staff, proximity to jobsite, and years of experience of each technician.
- Marked copy of specification, with exceptions clearly highlighted and guarantee of compliance to specification where exceptions are not noted.
- Written guarantee to cover any additional site installation costs associated with the supply of the proposed alternative. If a different product is submitted, ALL mechanical, electrical, architectural and structural modifications which
