Question 1

Will standing offers be awarded based on one provider bidding and winning on all products or are they awarded separately.

Answer 1

The standing Offer will be awarded on an aggregate basis in accordance with the basis of selection.

Question 2

Is the bread in this requirement fresh or frozen?

Answer 2

This requirement is for frozen bread.

Question 3

4.1.1.1 Mandatory Technical Criteria

Must provide pricing for a minimum of 90% of the 411 items listed. Does this apply to a combined total of all offerors or just to our submission?

Example 41 items are allowed with no quote to still be compliant – if there are 5 Offerors and each of us go with a “no quote” on 20 items unique from each other (total of 100 items), is our quote of 391 items still compliant to the terms?

Answer 3

Each Offeror must submit at least 370 items (90% of 411 items) to be deemed compliant with this technical evaluation criterion. However, only items common to all Offers will be used for the purpose of financial evaluation.

Question 4

Page 19 – 1 – Offerors must save a copy of the completed EFOT in Excel on a CD...

Question 5

In Annex B – how many decimals do you want us to use?
Example: #312 - Creamers 10% - it appears that you wish the price to be by the ML? With a potential sell price of \$20.00 for a case, the price per ML would be \$0.003125. Due to the small measure, we would need at least 6 placeholders to provide an accurate price. Page 21 P – indicates all values will be rounded to 2 decimals – this would then be \$0.01 – which would give a sell price of \$64.00 per case - \$44 over what we wanted to quote. Could you please provide some insight on this?

Answer 5

Canada is seeking prices for “Offered Packaging Option” for example a case of apples or a case of creamers or 12 cans of soup. All unit prices are derived through automated calculation.

P) Price per Offered packaging option

Purpose: This field represents the price for the packaging option for the line item as described in columns I through O. Example (price for a box 16 x 454 grams of product “x” with a total weight of 7.264 kg)

Input Instructions: The Offeror must enter a numerical value which represents its firm price for the line item offered in dollars and cents separated by a period (23.12) without any spaces, dashes or special characters. All values submitted will be rounded to 2 decimals
