Or, would one preclude vendors from bidding/working on the other?</p>	<p>While Proponents are encouraged to submit proposals in response to any Trent-Severn Waterway (TSW) opportunity for which they feel they are suitably qualified, Proponents are advised that Conflict of Interest clauses, applicable to the Consultant agreements, preclude a single Proponent firm from assuming the role of Design or Prime Consultant and Construction Manager for the same project (i.e. TSW Central Bundle, TSW South Bundle, etc.).</p> <p>A Consultant may not work on the design portions of a TSW opportunity in addition to providing the corresponding construction management services. Working as a Design or Prime Consultant precludes eligibility as Construction Manager, and vice versa.</p> <p>In the event that a Proponent submits proposals in response to both the Prime Consultant and Construction Management Request for Proposal(s) (RFP) for the same project (i.e. the Prime Consultant RFP and Construction Management RFP for the TSW South Bundle), and is determined to be the successful Consultant/Contractor pursuant to both solicitation processes, prior to award, the Proponent will be given the opportunity to withdraw either their Prime Consultant or Construction Management proposal.</p>
