SOLICITATION AMENDMENT 005

This document includes answers to questions received from potential bidders and an amendment.

Q.17 Given the extensive requirements and considerable level of effort required to prepare a high quality response, would the Crown please grant a 2 week extension?

A.17 Canada has reviewed the request and the closing date has been extended. See amendment below.

Q.18 Re: Mandatory requirements (1.2.4) and point rated requirements (2.2.4) for work stream #1 Technology Architect.

Upon review of the mandatory and point rated requirements for "Technology Architect – Specialty in IBM Master Data Management (MDM) Configuration and Release Management", we would suggest that the Crown may be unnecessarily narrowing the field of suitable candidates. Given that an IBM MDM application is essentially a Java/JEE application deployed using the WebSphere Application Server (WAS or WAS ND) management console, the primary skills required to configure and release an MDM solution implementation are the same for other large scale, enterprise class Java/JEE applications. In light of this, we recommend that the Crown modify its requirements on this category per our suggested modifications below:

1.2.4 Technology Architect - Specialty in IBM Master Data Management (MDM) Configuration and Release Management
M2:

Proposed Revised wording:

A minimum of three (3) years of experience, within the last ten (10) years, working as a technology architect specializing in software build and deployment processes, and automated builds and continuous integration for a JEE based integrated project solution implementation, aligned with a Service Oriented Architecture (SOA), on large scale projects (project value of \$6 million or greater) at an enterprise level with multiple stakeholders (greater than 2).

2.2.4 Technology Architect – Specialty in IBM Master Data Management (MDM) Configuration and Release Management
R1:

Proposed Revised wording:

Experience, working as a technology architect, within the last ten (10) years, developing, implementing and maintaining automated build and load deployment scripts for a JEE based SOA project.

R2:

Proposed Revised wording:

Experience, within the last ten (10) years, performing the maintenance of JEE SOA based project application source code repository.

R3:

Proposed Revised wording:

Experience, within the last ten (10) years, working as a technology architect on projects that required the integration, deployment, and configuration of a JEE based SOA solution for a government* client.
*Government may include the Federal, Provincial or Municipal Government. The Government of Canada includes any department, agency, board of the Government of Canada or a Crown corporation.

Q.19 Re: Bid Submission Date

Given that the responses to our questions may have a material impact not only on our technical proposal but also on our proposed pricing, we respectfully request an extension to the close date of two weeks so that we may have sufficient time to prepare a complete and compliant proposal.
