- Q4 For clarification, for pricing, you are only looking for Per Diem rates for Stream 1 and 2 (but not broken down to the individual activities below each)?
- A4 Correct.
- Q5 Since this is a RFSA, is the notion that vendors who can support the various regions they can will respond or are you looking for vendors that can serve your needs nationally? If the latter, are there travel costs that we need to identify or would it be per government travel policies or is the per diem to include travel costs as well?
- A5 As per the SOW, no Travel will be reimbursed. It should be absorbed by your costs.
- Q6 Could you let us know if there is an incumbent(s) and what the annual spend previously was?
- A6 No incumbent.
- Q7 Is Part 3 Section IV 3.1.1.1 required for this submission, or only necessary for specific Work resulting from being a Supplier? If an address is required, should the submission follow the same Arrangement Preparation Instructions as Sections I. II and III in Part 3.1?
- A7 You need to meet the Security Requirements prior to any contract being issued for specific work.
- Q8 Under Part 4, can we submit more than 2 project examples? Some of our project examples meet most of the points in Stream 1 and Stream 2, but not all.
