AMENDMENT 002

This amendment is raised in order to A) modify the Request for Proposal (RFP) and B) answer Bidder Questions:

A) MODIFICATIONS:

At ANNEX "A" STATEMENT OF WORK,

DELETE: *For the production in High Definition of twenty-six (26) video programs On Canadian Armed Forces trades and professions*

INSERT: *For the production in High Definition of Video Programs On Canadian Armed Forces trades and professions*

B) QUESTIONS:

Question 17: Annex A: Statement of Work mentions "For the production in High Definition of twenty-six (26) video programs on Canadian Armed Forces trades and professions". However, the number of videos seems to add up differently under A.2 Product and Service Required.

- 1) We understand that filming is required for up to 18 interviews (no editing required).
- 2) Each Occupation (9 Military Occupations listed under A.4.1) requires an English video and a French video (3-5 minutes each). Totaling 18 videos.
- 3) 30 second versions in both English and French are required for the trades and professions listed in clause A.4.1 (9 Military Occupations). Totaling 18 teaser videos.

All together we have 36 videos + filming of 18 interviews. Is this the correct number of expected video programs?

Answer 17: Please remove twenty-six (26) from the title of the Statement of Work.

The initial contract period is for up to eighteen (18) occupational video productions for nine (9) military occupations (each occupation will have an English video and a French video). Each video will have two (2) interviews.

ALL OTHER TERMS AND CONDITIONS OF THE SOLICITATION REMAIN THE SAME.
