PART 1 - GENERAL INFORMATION

1.1 Requirement

Acoustic Fish Profilers

Fisheries and Oceans, St. John's, NL requires delivery of Acoustic Zooplankton Fish Profilers (AZFP's) and associated equipment.

The Autonomous Acoustic Detection System is a system designed to take acoustic measurements of the water column on a mooring which detects organisms in the using the reflection of acoustic signals. While being moored at the bottom, the units send a signal to the surface and is reflected back to the device. When an organism is in the path of the signal, it reflects differently depending on the type of organism and its size. Depending on the frequency of the transducer, the user can measure various sizes and types of organisms that are in the path of the signal. It is the intention to have several different types of frequencies measuring concurrently to be able to look at the ecosystem through the usage of several frequencies at one time. Therefore, we require several transducer-transceiver systems synchronized together which this equipment is configured to do. We also would like to have the mooring frame and type specified as recommended by the manufacturer as there are several ways that it can be mooring based on the technology and company's experience.

1.2 Debriefings

Bidders may request a debriefing on the results of the bid solicitation process. Bidders should make the request to the Contracting Authority within 15 working days from receipt of the results of the bid solicitation process. The debriefing may be in writing, by telephone or in person.

1.2 Canadian Content

The requirement is limited to Canadian goods and/or services.

PART 2 - BIDDER INSTRUCTIONS

2.1 Standard Instructions, Clauses and Conditions

2.3 Former Public Servant – Competitive Bid
