Bidders may be requested to sign an attendance sheet. Bidders who do not attend or do not send a representative will not be given an alternative appointment but they will not be precluded from submitting a bid. Any clarifications or changes to the bid solicitation resulting from the site visit will be included as an amendment to the bid solicitation. No questions will be addressed during the visit, any questions should be submitted to the contracting authority no later than November 10, 2016, 4 PM (Eastern Standard Time)

Q2- Is there any requirement for Bill 7?
