Q6: Question: What is the NSN and what are the destinations?

A6: There are no NSN's associated to this required.

Q8: Is the vendor expected to hold the unit pricing until March 31st, 2017 and beyond for additional call ups of product as Itemized above and beyond the existing quantities as requested?

A8: *Bidders will be required to hold their pricing for a maximum of ninety (90) calendar days from date of bid closing. This requirement does not contain an optional goods clause. As such, bidders will not be required to provide pricing after the initial offered delivery date. March 31st 2017 is only the requested completion date. Bidders are encouraged to provide their best date of delivery.*
