SPECIFICATIONS

Section 01 35 54

Delete clause 1.1.1.3 entirely

Delete clause 1.1.2.1 "Submit necessary documentation required and obtain security clearances for all workers;" and replace with new sentence to read: "Submit necessary documentation required and obtain and pay for the services of security personnel, employed by the Canadian Corps of Commissionaires to provide escort and security supervision of all workers as specified in this section"

Delete clause 1.3.1.1 "Apply for PWGSC personnel security clearance screening and obtain a reliability status." and replace with new sentence to read: "Commissionaires to verify all contractor employees per clause 1.2.3"

Delete clause 1.3.2 "Persons that do not have security clearance, as specified above, will not be allowed to circulate freely in restricted areas of site and must be under constant escort and surveillance by security personnel." and replace with new sentence to read: "Any persons working for the General Contractor, or subcontractor(s), or material supplier(s) or hired by the Contractor for any portion of the work; will not be allowed to circulate freely in restricted areas of site and must be under constant escort and surveillance by security personnel"

Delete clause 1.3.3 entirely

Delete clause 1.3.4 "Escort and supervision functions specified herein is still required on the project after workers having obtained security clearance." and replace with new sentence to read: ".3 Escort and supervision functions specified herein is still required on the project even if some workers have obtained security clearance."

Delete part 1.4 (SECURITY CLEARANCE APPLICATION) entirely
