Questions & Answers:

Q: Is it possible for us to visit the site?

A: Yes, Site is an Open Area – No approval necessary.

Q: The RFP on page 9 states Forty pages for the Technical submission but the number 30. Which is correct?

A: See Revised RFP: The maximum number of pages (including text and graphics) to be submitted for the Rated Requirements under Technical Evaluation – Mandatory Technical and Point Rated Criteria Annex D is [forty (40)] pages.

Q: The RFP on pages 11 & 12 refers to tables 6 & 7 of Annex B however Annex B only has tables 1 to 5. Can you please a revised copy of Annex B with all tables included?

A: See Revised RFP. Tables 6 & 7 included.

Q: In Annex B Table 2 should column D not already have a value of \$16million in this cell as it is shaded?

A: See Revised RFP

Q: In section 1.1.4 of the technical submission the last four bullet points which are to be addressed in our response (schedule, tendering, commissioning and health & safety) are duplicated in section 1.1.5.1. Is it acceptable to respond in section 1.1.5.1 only?

A: Yes, if information is duplicated, you may respond in one section only. However, please ensure there is a reference made to where the information is provided in response to the specific requirement and evaluation criteria.

Q: Which is the correct address for the site 2260 or 2660 Speakman Drive as the two tender documents contradict one another?

A: The Address is 2260 Speakman Drive, Mississauga, Ontario

Q: In section 5.1 of the RFP item viii notes supplementary conditions to the contract. Are the supplementary contract conditions items 5.2 - 5.12 (pages 15 - 26) or are there any further supplementary conditions we need to be provided with.

A: Refer to Part 5 – Resulting Contract Documents.

Q: Regarding Section 1.1.2, sub 1.1.2.2 re: Experience and suitability of proposed staff: Please clarify/confirm:

- 4 page max for CM CV and 4 page max for PM CV;
- 2 page max for all other staff; and
- CV are not within 40 page proposal limit noting that, accounting for all required positions, the CVs alone will consume 16 pages of the document.

We respectfully request that CVs be excluded from the page count.

A: The CV's will not be excluded from the page count. We have requested a maximum allowance for the CV portion of the proposal to not exceed 16 pages (as per the breakdown included under 1.1.2.2). If the CM can convey their experience in a lower page count than 16 pages, it will be accepted.

Q: On page 55 of the RFP supporting document named "CM RFP Research Lab Bldg_Att2_Sept27" it states "No parking on site". Is this statement applicable? Due to the site location and from our site visit this is not feasible and we would need to use existing areas on the site for parking.

A: Parking is allowed onsite at 2260 Speakman Drive during the timeframe of the work.

Q: For clause GC1.6 (2008-05-12) Indemnification by the Contractor we would like to request the Supplementary Conditions include SC03 LIMITATION OF LIABILITY. This SC03 Limitation of Liability clause has limits established for non-insurable events at the greater of the Contract Amount or \$5,000,000, but in no event greater than \$20,000,000.

A: These are PWGSC Standard clauses and cannot be altered.

Q: For clause GC5.10 (2007-05-25) Assessments and Damages for Late Completion. In regards to 5.10.2.c, limiting this to direct expenses and damage is more commonly accepted industry practice. Can this clause be amended to reflect direct expenses and damages?

A: These are PWGSC Standard clauses and cannot be altered.

Q: Form 1: Is there a minimum Security Clearance Level required of the Bidder to be awarded the project?

A: Security Clearance is not a requirement at this time.

Q: "Consultant Team Identification". Please define Consultant.

A: See Revised RFP. Delete "Consultant Team Identification" and Insert "Proposed Team Resumes".
