## ADVANCE CONTRACT AWARD NOTICE (ACAN)

#### 1. Title

Building Automation System upgrade and modifications to the Air Handling Unit 3-01 supplying the Warehouse #2 in order to maintain and sustain the prescribed Collection's Environmental Conditions for Fossil Invertebrates

# 2. Advance Contract Award Notice (ACAN)

An ACAN is a public notice indicating to the supplier community that a department or agency intends to award a contract for goods, services or construction to a pre-identified supplier, thereby allowing other suppliers to signal their interest in bidding, by submitting a statement of capabilities. If no supplier submits a statement of capabilities that meets the requirements set out in the ACAN, on or before the closing date stated in the ACAN, the contracting officer may then proceed with the award to the pre-identified supplier.

### 3. Definition of Requirements

Lar-Mex Inc. has been identified as the contractor for the maintenance, verification and service of all building automation control devices and operating software installed at the Canadian Museum of Nature (CMN) research facilities located at Pink Road, Gatineau. The contract between CMN and Lar – Mex is in effect until November 30, 2017.

NRCan has a partnership agreement (MOU) with CMN to house the NRCan National Geological Reference Collection in modern curation facilities to realize whole of government cost efficiencies in managing scientific collections. Rehousing the collections with the CMN collections will enable improved accessibility and curation of the NRCan collections and maximize their scientific value. To meet deadlines and ensure cost efficiencies there is a requirement to be compatible with the existing CMN infrastructure and suppliers. Lar-Mex was selected by CMN as the most cost effective supplier and installer of this specialized air handling system required to maintain environmental conditions in accordance with international curation standards.

### 4. Tasks, Deliverables, Milestones and Schedule

There are several phases to the Statement of Work which include:

- Supply and install one heating coil according to specifications provided by the Canadian Museum of Nature and to match the Lar –Mex existing HVAC system.
- Remove a portion of the existing duct work to allow the installation of a larger duct to connect on the new specified duct
- Supply and install the required duct work to connect to the existing Lar Mex air handling unit and the supply duct going into the warehouse #2 space
- Supply and install the required piping to connect to the existing Lar Mex air handling system after the
  3 way valve to the new heating coil location and meet functional requirements specified by CMN regarding temperature and humidity sensors
- Supply and install temperature and humidity sensors including installation of wiring and additional sensors
- Provide the technical labour to perform installation, system commissioning to match Lar Mex existing standards
- Provide balancing report wet and dry, fan pulley and motor and labour to update the as built and building automation graphics

## 5. Criteria for Assessment of the Statement of Capabilities

Any interested supplier must demonstrate by way of a statement of capabilities that it meets the recognized standard (certification) associated with this particular program by satisfying all of the following criteria:

- The proposed contractor must provide installation (including programming) services in order to upgrade & modify the existing Building Automation System provided by Lar-Mex Inc.
- The proposed contractor must provide the installation so as to result in a final extended Air Handling unit for which Lar-Mex would be willing to accept full responsibility for its operational effectiveness.
- The proposed contractor must provide an extension that will fully meet requirements of interchangeability with already existing equipment or services.

## 9. Justification for the Pre-Identified Supplier
