Question 1: Where will trips originate from?

Question 2: There is a driver that I would like to propose for this contract and one of the requirements at mandatory technical criterion M5 on page 25-26 of the RFP is that I provide a copy of his passport. This driver's passport had expired recently and he sent in the renewal documents but has not yet received his replacement passport. In the event the driver does not receive his renewed passport before the closing date of the bid solicitation, will you accept a copy of his existing expired passport, then a copy of his renewed passport later if I am the successful bidder or will submitting a copy of his expired passport disqualify my bid?

Answer 2: An expired passport will not be accepted. A valid passport is required before the closing date of the bid solicitation.
