This amendment is being raised to extend the closing date and answer questions to date.

Q1. - Under SOW, item 6.4.5 requests that the testbed and data files be provided as deliverables. Given the budget and the likely fact that effort to develop a testbed will required development investment funded by other sources, we respectfully request that this deliverable be removed or amended to only refer to data that is generated from the DRDC Toronto study using the contractor's testbed.

A1. - Only the data files are required as a deliverable.

Q2. - Annex B Basis of payment indicates that the financial evaluation will only be based on a consideration of a firm, fixed price for the entire contract period. Is it sufficient for bidders to provide this single firm, fixed price figure, or does the Crown have additional guidance for the bidder's presentation of financial information?

A2. – Only the information requested in the Annex is required.

Q3. Will the Crown please confirm that the research questions listed in Annex A Statement of Work Section 2 Background represent examples and not an exhaustive list of research questions, and that the successful bidder will work with the technical authority to choose the most appropriate and viable research questions to be investigated experimentally using the testbed?

A3. - Annex A only represents a sample of questions. The successful bidder will work with DRDC to refine and prioritize the most appropriate and viable research questions to be investigated experimentally using the testbed.
