AMENDMENT 006

The purpose of this amendment is to:

Part A) Respond to bidder's questions:

Question 28: Is there applicable unions towards the venue of the event, in particular for the technical staff (ex: IATSE) in reference to the Annex A, section 1.2 second last paragraph; and article 4.1.3 c)

Answer 28: No, there is no requirement about specific unions for the technical staff. Please refer to section 1.2 for any other union questions.

Question 29: in reference to section of the Annex A, 4.1.2 a), f); and 4.1.4 k), here is our questions:

A) Who ultimately is the broadcast producer?

Answer 29a: PCH is the executive producer of the broadcast.

B) Which are the names of collective agreements applicable to the respect: i) of the "live" performance on stage and ii) of the TV and Web broadcasting of the event?

Answer 29b: Please refer to section 1.2 and section 4.1.2.f.

C) Who is the entity responsible for signing contracts resulting from these collective agreements?

Answer 29c: It's the responsibility of the Event Production Team.

Question 30: In reference to section 4.2.3 a) Is it PCH who will sign the agreements with the ACTRA and other unions with the artists who will perform during the broadcasting of the show

Answer 30: No, it's the Event Production Team responsibility.
