## **Questions and Answers**

**Question # 1: We cannot seem to be able to locate an associated Statement of Work that describes the printing specifications for the books – i.e. number of pages, colors, type of paper, etc. Are there printing specifications available for this Request for Proposal (RFP)?**

**Answer # 1:** There is no associated Statement of Work, all the requirements are already present in the RFP document. We do not have any artwork available. We are looking for the actual civilian publications that have already been produced and the intent is to purchase those books.

**Question # 2: There is no information in the RFP regarding the method of binding each book. Are they perfect bound or saddle stitched, or just placed in a binder? This is required to produce a quote.**

**Answer # 2:** There are different types of bindings already available in the market for these publications. As long as the exact publications are being provided, the binding can be in any form.
