**Q.1** Can you advise if there is currently, or has been in the last 18 months, a firm that provided similar resources for similar work? If so, please advise the name of the firm, contract duration and when the contract was completed or if it is still in progress. What is the Contract value? Is the current incumbent invited on the list of vendors?

**A.1** Work of similar nature is being carried out by *Confluence Consulting* under contract number 24062-12-243 for a total cost of \$2,368,956.00. The contract duration is three years ending November 30, 2016. All TBIPS SA Holders currently holding a TBIPS SA for Tier 2, in the National Capital Region under the EN578-055605 series of SAs are eligible to compete.
